TAKEOVER DECLARATION AND RENTAL CONDITIONS (BOAT)

These items belong solely to the rented boat and must remain on board.

The renter must use the boats and equipment carefully and only for their intended purpose. The maximum allowable number of participants must be adhered to.

The boat operator is responsible for ensuring that a life jacket is on board for each person and returned to storage after the trip. Life jackets must be worn when the boat is in motion.

The boat operator is personally liable for all damage to the boat, engine, and accessories. Missing items will be replaced at the operator's expense.

The boat is fully insured with a 1500€ deductible per claim.



If fishing line gets caught in the propeller, the operator must immediately notify the supervisor. Damage can be avoided with prompt action.

IMPORTANT: Insurance is void in case of negligence and the operator is fully liable. Negligence includes failing to maintain a minimum water depth of 2 meters. The installed depth sounder may show incorrect depths; the operator is responsible for checking depth.

ABSOLUTE ALCOHOL BAN FOR OPERATORS (0.0per mille) IN NORWAY! See "Guest Information - Fishing and Safety in Norway." A second person (0.0per mille) is required for docking manoeuvres. OPERATOR AND DECKHAND ARE FULLY LIABLE FOR DAMAGES IN CASE OF ALCOHOL VIOLATION.

The rental provider may cancel the contract at any time for cause, especially if renters are under the influence of drugs or alcohol or pose a risk to themselves or others.

Insurance coverage lapses in case of alcohol use.

WEATHER CONDITIONS

The rental provider is not liable for weather conditions. Unless otherwise agreed, the rental contract remains valid regardless of rain or unusual seasonal temperatures.

Use of boats is prohibited from wind force 5 or when such conditions are forecasted. The renter must check weather conditions independently. When in doubt, clearance must be obtained from the supervisor.

Boating is prohibited when a black flag is raised on the dock! Violations void the insurance coverage.

NO RIGHT TO REPLACEMENT BOAT IN CASE OF USER-CAUSED DAMAGE

If the renter causes damage to the boat through misuse, safety violations, or gross negligence, there is no right to a replacement boat or partial refund.

DISCLAIMER OF LIABILITY

Rental company liability for non-bodily damages (including pre/post-contractual breaches) is limited to three times the rental price, unless caused intentionally or by gross negligence.

No limitation applies to damages from injury to life, body, or health due to negligent or willful breach of duty by the rental company or its representatives..

JURISDICTION

The renter may sue the rental company (10 Miles North AS) at its place of business. Lawsuits against the renter are based on the renter's residence, unless the renter moved abroad or their residence is unknown, in which case the jurisdiction is the rental company's location.

DATA PROTECTION

Personal data shared during the rental relationship is used solely for processing and fulfilling contractual obligations.

- ☐ *I have been informed about routines on how the boat hire company might contact me while at sea*

Nautical charts and waters

- ☐ *If the facility has specific route charts, I have been given instructions on how to use these charts*
- ☐ *I have been given information on traffic restrictions in the area*
